 - 1. Correspondence
 - VIAHA Memo: Coach Suspensions & Treatment of Volunteers
 - Lots of appeals to suspensions
 - Nothing to do with Peninsula
 - Sent out the memo anyways
 - 2025 VIAHA Awards and Nominations
 - VIAHA Memo: U11 Recreational League Playoffs
 - Peninsula is hosting C playoffs
 - Moving from tournament to 4 teams in semis and 2 in finals
 - Same as U13, 15, 18 house playoffs
 - Peninsula Panther Fan Appreciation poster
 - 2. Committee & Director Reports
 - President Lindsey (see attached)
 - If don't live within the residential boundary you have to apply to play in a different association
 - Petition to move the line, closer to Sayward, and amend the boundary
 - Traffic is hard for parents to get to other arenas
 - Estimate 10 more players
 - South Island Presidents meeting on February 24
 - clearer language in VIAHA policy
 - U11 and U9, 25% for trying out, recreation for all levels
 - Meeting next week about Tier 1 zone program
 - This last year we lost 14 U15 players and 8 U13 players (not U18)
 - VRC President and VMHA (Admirals) President, Peninsula Presidents are in agreement
 - Discuss challenges, strengths, opportunities for the players
 - They started a pilot program in Comox, Campbell River
 - JDF is not interested, they currently pull Sooke and Kerry Park
 - Currently the tier 1 system decimates our small association, need larger association who pull only a few other players from somewhere else
 - Player pays their home association, if make the tier 1 team, they get their fees returned and they pay VRC currently
 - If combine, whoever has most players is the host association and fees get paid to them
 - Committee would decide on coaches, ice, games, budget

- 3. New Business
 - VIAHA suspensions for coaches whose teams exceed 26 penalty minutes
 - Last year, the rule was changed from 36 to 26 minutes
 - If your team exceeds 26 penalty minutes in a game, not including majors, the head coach gets a 1 game suspension
 - This happened to 2 coaches at PMHA this year
 - Discussed that not all penalty minutes are not equal; tripping, hooking, too many men, delay of game versus head contact, boarding, cross checking
 - Does this rule penalize the coach for something they already get penalized for such as being short handed
 - Spirit Rally Update
 - Teamlinkt discussion
 - Chelsea brought this forward to use as learned from One Click, met with them this morning
 - Benefits to switching from TeamSnap
 - Canadian currently
 - Savings
 - Advertise being free (team snap is \$1200/year) but would probably need to pay some power ups, and includes a tournament platform which we currently pay \$426, website is included
 - First year fee would be \$800
 - We paid \$13,000 in TeamSnap fees
 - TriPort and West Kelowna are using it, reached out to find out what it's like
 - Waive the \$5 API fee for 1 year
 - Collaborates with QuickBooks
 - Challenging to implement now for registration for 2025/26
 - Probably best to review this for next year
 - In camera discussion
 - RIC stipend
 - PMHA pays the RIC a stipend each year, increased it to \$5000 last year
 - Treasurer emailed RIC to confirm payment would not be in February, he agreed and expected it in March
 - \circ $\;$ RIC expects \$7000 this year, and each year going forward
 - Would like an annual report, disciplinary issues dealt with, coaching and mentoring
 - Motion: To approve the final \$2000 increase to the RIC stipend for the final increase to \$7000 per year and for the 2024/25 season to be paid out of referee wages budget by Jenn H seconded by Jenn M, CARRIED
